### HG hygienic whirlpool bath cleaner

Due to use of your whirlpool, the internal system becomes soiled with limescale, soap residue, grease and skin oils. *HG hygienic whirlpool bath cleaner* has been developed on the basis of natural materials, such as lactic acid and Australian tea tree oil, and cleans the whirlpool hygienically and safely without affecting the internal system or the environment. Caked-on contamination is naturally and effectively removed. Regular use of this product extends the lifespan of the whirlpool.

#### Directions for use:

**For whirlpools with internal semi-automatic cleaning systems:**

1. Fill the internal cleaning system with *HG hygienic whirlpool bath cleaner*.
2. Follow the directions for use of your whirlpool.

**For whirlpools without internal cleaning systems:**

1. Fill the whirlpool with warm water to 5 cm above the highest openings of the water or air jets.
2. Pour 50-75 ml of *HG hygienic whirlpool bath cleaner* directly into the bath.
3. Turn on all the systems for 15 mins.
4. Empty the bath and rinse with clean water. Repeating the treatment with clean water is not necessary. To prevent the build up of dirt it is advisable to clean the whirlpool every 2-3 weeks, depending on usage.

**Coverage:** 50-75 ml per use.

### Attention: Transport and store the bottle upright.

If you wish to remove the smell of *HG hygienic whirlpool bath cleaner* from the system, repeat the treatment with clean water.

If your whirlpool has not been cleaned for some time, use 250 ml once only.

Do not allow any undiluted product or bathwater mixed with this product to come into contact with calciferous and non acid-resistant surfaces, such as marble.

Keep in a frost-free area.

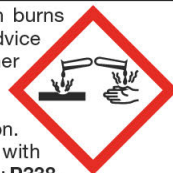
